#### PROCEDURAL HISTORY

On November 20, 2006, the Department of Regulation and Licensing issued an Order granting Respondent a limited license (#108-28605) to practice as a private security person in Wisconsin. The Order provided that failure by applicant Koller to timely comply with the terms of this limitation may result in the revocation of his limited private security permit without further notice or hearing or other proceedings.

Mr. Koller has failed to file the required quarterly reports with the Department.

### **ORDER**

NOW, THEREFORE, IT IS HEREBY ORDERED that the limited private security permit of Randolph C. Koller (#108-28605) is REVOKED.

This Order shall become effective upon the date of its signing.
