REINSTATEMENT AND GRANTING

On January 25, 2007, the Wisconsin Board of Nursing considered the petitioner's request for full reinstatement of her limited license or a stay of the suspension of her license for a further period of three months. The petitioner also requested a reduction the frequency of her drug screens and termination of her therapy requirement. Based upon all information of record herein, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for full reinstatement of the license of ROBIN J. SWIGGUM, RN, (lic.#119898), to practice as a registered nurse in Wisconsin, is hereby DENIED. The denial of petitioner's request is because she has only had two years of compliance with her order. The five year period of limitations began on December 17, 2004.

IT IS FURTHER ORDERED that the petitioner's request for reduction in drug screens and termination of therapy is hereby GRANTED. Petitioner's drug screens shall be reduced to forty-two (42) per year and her therapy requirement shall be terminated, as supported by her therapist. This Order is effective upon the date of signing.
