On February 7, 2007, the Board reviewed the January 16, 2007, order of the Board Liaison for Monitoring terminating the stay of suspension of Gregory J. Teche, R.Ph. As reported by the department monitor to the board liaison for monitoring, Gregory J. Teche has been suspended by his drug and alcohol monitoring program, ("Approved Program") from November 27, 2006, to January 16, 2007. Teche also failed to provide a urine sample for drug and alcohol screening on the following dates: 11/27/2006, 11/30/2006, 12/01/2006, 12/05/2006, 12/11/2006, 12/12/2006, 12/14/2006. The board also reviewed correspondence from Teche's therapist dated January 26, 2006, (sic) indicating that Teche had reported using alcohol on several different occasions during the reporting period. The therapist provided a prognosis of "guarded/poor. Teche's suspension from his Approved Program and failure to provide a urine sample as required by Board's *Final Decision and Order* dated November 12, 2002. ("*Order*"), and his use of alcohol violates paragraph 2b(4)d ad 2a of the *Order*, respectively.

IT IS HEREBY ORDERED: the January 16, 2007, order of the Board Liaison for Monitoring terminating the stay of suspension of Gregory J. Teche, R.Ph., is AFFIRMED. Pursuant to paragraph 8 of the *Order*, the stay of suspension for Gregory J. Teche, R.Ph., license number 10612, to practice pharmacy in the state of Wisconsin, is hereby continued TERMINATED by action of the Board and Gregory J. Teche remains SUSPENDED from the practice of pharmacy in the state of Wisconsin.

IT IS FURTHER ORDERED: that for purposes of compliance with the *Order* Teche shall recommence compliance with the *Order* with a new start date of February 7, 2007, and all original terms and conditions of the *Order* shall apply, with all prior modifications of the *Order* being revoked.

IT IS FURTHER ORDERED: Teche shall not be permitted to request a further stay of suspension until providing proof of compliance to the board of a minimum of six (6) months compliance with all original terms and conditions of the *Order*, beginning from February 7, 2007.
