On February 14, 2007, the Medical Examining Board considered the petitioner's request for full reinstatement of his license, which had been deferred at the previous meeting, pending further review. The information considered by the Board included the petitioner's monitoring report and report from petitioner's current health care provider concerning the stability of the petitioner's recovery, the length of his continued sobriety and the full and sustained remission of his addictive disorder. Based upon the information of record, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for full reinstatement of the medical license of Robert A. Vincent, M.D. (lic. # 17720) is hereby GRANTED.

This Order is effective upon the date of signing and all limitations upon his license shall be removed.
