FULL REINSTATEMENT AND

On March 8, 2007, the Land Surveyors Section of the Examining Board of Architects, Landscape Architects, Professional Engineers, Designers and Land Surveyors considered the petitioner's third request for full reinstatement of his land surveyor license (# 1295).

The petitioner's license had been originally suspended and limited pursuant to the Section's order dated November 13, 2003. On March 1, 2006, the Section issued an order denying full reinstatement and modifying the terms and conditions of the petitioner's limited license regarding remedial continuing education and supervision of his land surveying practice, based upon petitioner's failure to comply with his Board order.

Based upon the information of record presented showing that petitioner has still not achieved compliance with the remedial continuing education and supervised practice requirements of the Board's latest order or his previous order, the Board finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for full reinstatement of the license of JOHN R. KARNS (#1295) to practice as a land surveyor in the state of Wisconsin is hereby DENIED.

IT IS FURTHER ORDERED that the petitioner's license shall be suspended for failure to comply with his Board order.

IT IS FURTHER ORDERED that this matter shall be referred to the Division of Enforcement for additional disciplinary action.

This Order shall be effective upon five (5) days of the date of signing of this order.
