On November 1, 2006, the State of Wisconsin Dentistry Examining Board reviewed the petition by Gregg A. Seyler, asking the Board to stay and modify the terms of an Order dated January 7, 2004, that imposed discipline on Dr. Seyler. Dr. Seyler asked the Board to reduce his random urine screens from 60 to 40 times a year and to reduce the frequency of required therapy sessions from weekly to biweekly. The Board reviewed the materials submitted by Dr. Seyler. Based on the review of the record the Board issues the following Order.

IT IS HEREBY ORDERED that Dr. Seyler's petition for a three month stay of the January 7, 2004, Order is Granted beginning on November 1, 2006, and that Dr. Seyler's petition to reduce the frequency of required therapy sessions from weekly to biweekly is Granted.

IT IS ALSO ORDERED that Dr. Seyler's petition to reduce the number of required random urine screens is Denied.
