On January 25, 2007, the Wisconsin Board of Nursing reviewed the petitioner's request for full reinstatement of license, pursuant to the Board order dated April 22, 2004. The information showed petitioner has not been compliant with the terms and conditions for drug screens required under her order due to her unemployment. Based upon the information of record herein, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the stay of suspension of the license of ANNE E. ALLEN-HEATH (lic#87807) to practice as a registered nurse in Wisconsin shall be removed due to her non-compliance and her license shall be SUSPENDED. The petitioner may not re-petition for reinstatement of license until she is in full compliance with her order.
