On July 18, 2007, the Wisconsin Psychology Examining Board reviewed the petition of Kathleen M. Roblee to remove the limitations on her license to practice psychology and to restore full licensure in the state of Wisconsin. The Board found that Kathleen M. Roblee completed all of the conditions set forth by the Board in an Order dated May 5, 2004.

Following review and deliberation by the Board, the Board ordered as follows:

IT IS HEREBY ORDERED THAT, the limitations are removed from Kathleen M. Roblee's license to practice Psychology and that her license is restored to full and unrestricted status.
