On March 1, 2007, the Wisconsin Board of Nursing reviewed the petitioner's request for a three month stay of suspension pursuant to her Board Order dated July 29, 2004. Petition also requested a reduction in her AODA therapy and approval for access to administer narcotics. Based upon the information of record herein, the Board now finds and enters the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request of SANDRA R. OLSON for a three month stay of the suspension of her license (#119811) to practice as a registered nurse is GRANTED.

IT IS FURTHER ORDERED that the petitioner's request for reduction in her AODA therapy is GRANTED. The frequency of petitioner's therapy shall be bi-monthly.

IT IS FURTHER ORDERED that the petitioner's request for access to administer narcotics is GRANTED.

This Order is effective upon the date of signing and is continuous from the date of the previous stay.
