On September 12, 2007, the State of Wisconsin Pharmacy Examining Board reviewed a petition and supporting evidence submitted by Michael Hiller, R.Ph., in support of a request for the granting of a three month stay of suspension as provided within the board's *Final Decision and Order*, ("*Order*") dated August 11, 2004, in case number LS 0408114 PHM. Also requested was elimination of therapy sessions as required by paragraph 2.b.(2) of the *Order* (Currently one time per month.) The request for a reduction in therapy sessions was supported by Hiller's therapist. Also requested was the ability to open and close the pharmacy consecutively, unsupported by his employer. (Hiller currently has granted to him 16 hours per week as a pharmacist in charge but may not open and close a pharmacy consecutively.) Based upon the board's review of the petition and the documents submitted, the board orders as follows:

IT IS HEREBY ORDERED: that Michael Hiller, R.Ph., is granted a three-month stay of the suspension of license #10177 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED: that the request for reduction of therapy sessions as required by paragraph 2.b.(2) of the *Order*, is granted, to once (1x) per quarter.

IT IS FURTHER ORDERED: that the request for the ability to open and close a pharmacy consecutively, is denied.
