#### PROCEDURAL HISTORY

On December 6, 2007, the State of Wisconsin Chiropractic Examining Board reviewed the petition by Gregory M. Blau, D.C., for restoration of full licensure, pursuant to his completion of the requirements set forth in the Board's Final Decision and Order dated April 28, 2005.

#### FINDINGS OF FACT

- 1. On April 25, 2005, the Board imposed limitations upon Gregory M. Blau's, D.C., license to practice chiropractic.
- 2. On November 15, 2007, Gregory M. Blau, D.C., asked the Board to fully reinstate his license.
- 3. After review of the material presented to the Board about Gregory M. Blau, D.C., the Board finds that Gregory M. Blau, D.C. has completed all of the terms and conditions imposed upon his license by the April 25, 2005, Board Order.

### CONCLUSIONS OF LAW

The Chiropractic Examining Board has jurisdiction and authority in this matter, pursuant to Wis. Stat., s. 446.03.

#### ORDER

Based upon the Board's review, IT IS HEREBY ORDERED that the license of Gregory M. Blau, D.C., to practice Chiropractic in the State of Wisconsin, is hereby restored to full and unrestricted status.
