On April 2, 2007, the Wisconsin Barber and Cosmetology Examining Board (Board) reviewed Darshel R. Harris' petition for reinstatement of her apprenticeship permit. Darshel Harris' permit was suspended on June 20, 2006 for failure to comply with a December 6, 2004, Order of the Board. The Board had ordered Ms. Harris to pay \$4,000.00 in forfeitures and \$2,000.00 in costs to the Department Monitor and it established a payment schedule. Ms. Harris made no payments to the Department Monitor and as a result her apprenticeship permit was suspended.

On February 19, 2007, Darshel R. Harris submitted a letter to the Board asking to have a new payment schedule instituted. Ms. Harris states that she would like to pay her fines and return to work.

After deliberation, the Board decided to establish a new payment schedule for Darshel R. Harris and to lift the suspension of her apprenticeship permit if specific conditions are met.

IT IS HEREBY ORDERED THAT, Darshel R. Harris' apprenticeship permit will be reinstated if Ms. Harris pays \$1,250.00 to the Department of Regulation and Licensing by June 1, 2007. Beginning July 1, 2007, Ms. Darshel shall make monthly payments of \$300.00 to the Department until the \$6,000.00 plus prior interest is paid in full. The Department Monitor will tell Darshel R. Harris the full amount owed.

IT IS FURTHER ORDERED, that payments shall be made by certified check or money order, payable to the Wisconsin Department of Regulation and licensing and sent to: Department Monitor, Division of Enforcement, Department of Regulation and Licensing, PO Box 8935, Madison, WI 53708-8935.

IT IS FURTHER ORDERED, that if Darshel R. Harris fails to timely submit any payment as set forth above, Darshel R. Harris' apprenticeship permit will be suspended without an opportunity for a hearing and without further Order of the board. Failure to make a timely payment is a violation of this Order.
