On April 19, 2007, the Wisconsin Board of Nursing considered the request of the petitioner for a continuation of the stay of suspension of her nursing license. The Petitioner also requested modifications in her therapy and drug screens. Based upon the information presented, the Board finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a three month stay of the suspension of the registered nurse license of JENELLE M. DEBYLE, R.N. (lic. #125986) in the state of Wisconsin is hereby GRANTED.

IT IS FURTHER ORDERED that the petitioner's request for a reduction in her random drug screens is GRANTED. Petitioner's screens shall be decreased to thirty-one (31) times per year.

IT IS FURTHER ORDERED that the petitioner's request to decrease her therapy sessions is DENIED because the petitioner's therapist was not available to confirm whether or not the decrease was appropriate. This Order is effective upon signing and the stay is continuous from the date of the previous stay.
