On August 30, 2007, the Board of Nursing considered the petitioner's request for modifications in her therapy and random drug screens pursuant to the order of the Board dated November 10, 2005. Based upon the information presented showing therapist support for the modifications, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a decrease in the random drug screens for ALICE RUTH KAPANKE, R.N. (#30-49764), is hereby GRANTED. Petitioner's screens shall be decreased to thirty-one (31) per year. IT IS FURTHER ORDERED that the request for a decrease in the petitioner's therapy sessions is hereby GRANTED. Petitioner's therapy shall be decreased to one (1) session per month.
