On April 3, 2006, the Wisconsin Barber and Cosmetology Examining Board (Board) issued an Order Reprimanding the licenses of Plaza Barber Stylists and Johnny Santiago for having previously provided services without licenses. The Board assessed costs and forfeitures for a total amount of \$2,700 to be paid in installments. The Order provided for the suspension of the licenses if the Order was violated. Johnny Santiago failed to make any payments to the Board and as a result his and the salon's licenses were suspended on October 9, 2007.

On November 9, 2007, the Board received a Petition from Johnny Santiago asking for the reinstatement of both of the licenses and for an extension of time to pay the costs and forfeiture. On December 3, 2007, the Board reviewed Johnny Santiago's petition for reinstatement of his license and the license of Plaza Barber Stylists.

After deliberation, the Board decided to reinstate the licenses and establish a new payment schedule for Plaza Barber Stylists and Johnny Santiago.

IT IS HEREBY ORDERED THAT, the licenses of Plaza Barber Stylists and Johnny Santiago will be reinstated if a payment for \$100 is received by the Department of Regulation and Licensing before January 16, 2008. Beginning February 1, 2008, Mr. Santiago shall make monthly payments of \$100.00 to the Department until the \$2,700.00 is paid in full.

IT IS FURTHER ORDERED, that payments shall be made by certified check or money order, payable to the Wisconsin Department of Regulation and licensing and sent to:

IT IS FURTHER ORDERED, that if Plaza Barber Stylists and Johnny Santiago fail to timely submit any payment as set forth above, their licenses will be suspended without an opportunity for a hearing and without further Order of the board. Failure to make a timely payment is a violation of this Order.
