ORDER GRANTING A STAY OF SUSPENSION

On February 1, 2007, the Social Worker Section (Section) issued a Final Decision and Order in the above-captioned matter. By the terms of the Board's Order, Ms. Bukowski's certificate to practice as a social worker was suspended for a minimum of one year, subject to a petition for renewable stays of suspension provided Ms. Bukowski was in compliance with the terms of the Order. Among the conditions of the Order, Ms. Bukowski, upon initial application for a stay of suspension, had to provide proof that she completed a psychological evaluation and that she successfully completed an ethics course acceptable to the Section.

On June 27, 2007, the Social Worker Section reviewed the request of Julie Ann Bukowski for a stay of suspension along with other supporting documentation.

Based upon the Board's review,

IT IS HEREBY ORDERED that Julie Ann Bukowski is granted a one year stay of suspension to practice as a certified social worker in the State of Wisconsin.

IT IS FURTHER ORDERED that Ms. Bukowski remain in therapy with Barb Lonsdorf, Ph.D., as recommended by Dr. Lonsdorf or as recommended by a subsequent treatment provider. Ms. Bukowski shall arrange to have her therapist provide quarterly reports to the Section for its review.

IT IS FURTHER ORDERED that if Ms. Bukowski becomes employed as a certified social worker that she provide her employer with the Section's Final Decision and Order in the above-captioned matter and all subsequent, related Orders. Ms. Bukowski shall arrange to have her employer provide written quarterly work reports to the Section. Ms. Bukowski's employer shall inform the Section immediately of any unsatisfactory work performance matters.

IT IS FURTHER ORDERED that, unless otherwise noted, Ms. Bukowski's certificate to practice as a social worker remains subject to the terms and conditions as set forth in the Section's *Final Decision and Order* dated February 1, 2007, and any subsequent Section Orders.
