On March 14, 2007, the Wisconsin Psychology Examining Board reviewed the petition of Peter Weiss to remove the limitations on his license to practice psychology and to restore full licensure in the state of Wisconsin. The Board found that Peter Weiss completed all of the conditions set forth by the Board in an Order dated February 8, 2006.

Following review and deliberation by the Board, the Board ordered as follows:

IT IS HEREBY ORDERED THAT, the limitations are removed from Peter Weiss' license to practice Psychology and that his license is restored to full and unrestricted status.
