On August 30, 2007, the Wisconsin Board of Nursing considered the petitioner's request for a stay of suspension of her advance practice nurse prescriber certificate (APNP) to allow her to practice as certified registered nurse anesthetist (CRNA). In addition, the petitioner has requested approval for access to controlled substances at her workplace and a modification in her drug screens, including the interval for reporting and frequency. The petitioner's requests were made pursuant to the prior orders of the Board dated March 9, 2006 and December 19, 2006, which are currently in effect. Based upon the information of record and the verification of her health care provider regarding her ability to return to work as a CRNA, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a stay of the suspension of the certificate of JULIE A. WNUK, R.N., to practice as an advance practice nurse prescriber (# 33-623) in the state of Wisconsin is hereby GRANTED.

IT FURTHER ORDERED that the petitioner shall abide by the following limitations upon her practice as an APNP:

1. Petitioner shall work under the direct supervision of a licensed health care professional with a fixed schedule and shall not work "on call".
2. Petitioner may have access to controlled substances at her workplace but all controlled substances handled by the petitioner must be reconciled, including wastes, in a witnessed manner.
3. Petitioner shall submit to random drug screens at a frequency of one hundred and six (106) per year. The screening procedure shall include a testing interval of three (3) hours from the time of notification.

IT IS FURTHER ORDERED that all terms and conditions of the Petitioner's original Board order dated March 9, 2006, not inconsistent with or superseded by the additional limitations ordered herein, shall remain in full force and effect.

This Order is effective upon the date of signing.
