ORDER

NOW, THEREFORE, IT IS ORDERED that the request by Julie A. Wnuk (Trzebiatowski), R.N., A.P.N.P. (lic. #33-623) for approval of Progressive Anesthesiologists Solutions at Langlade Memorial Hospital, as her work site is hereby APPROVED.

IT IS FURTHER ORDERED that the approval of the work site is contingent upon a reconciliation of any controlled substances, including propfol, administered by the petitioner after each case, and this reconciliation must be performed by another licensed health care provider.
