On April 19, 2007, the Board of Nursing considered the petitioner's request for a decrease in her therapy requirement and a reduction in her random drug screens. Based upon the information presented, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for modifications to the limitations on the license of ERIN HOREJS, R.N. (#142262), is hereby GRANTED.

IT IS FURTHER ORDERED that petitioner's screens shall be reduced to forty-two (42) per year.

IT IS FURTHER ORDERED that petitioner's therapy shall be reduced to one or two times per month as needed.
