PROCEDURAL HISTORY

On August 2, 2007, the Secretary of the Department of Regulation and Licensing (Department) issued an Order Fixing Costs in the above-referenced matter. Under the terms of the Order Respondent Bridgit D. Geiger is required to pay the costs of the proceeding in the amount of \$13,117.06 by September 1, 2007. The parties in this matter agree to the terms and conditions of the attached Stipulation and the Amended Order Fixing Costs, subject to the approval of the Secretary of the Department. The Secretary has reviewed and approved the Stipulation agreement annexed to this Amended Order Fixing Costs. Accordingly, the Department adopts the attached Stipulation and makes the following:

AMENDED ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. Respondent **Bridgit D. Geiger** shall pay the costs of the proceeding in the amount of \$13,117.06 to the Department with a first payment to be made in the amount of \$3,117.06 by September 8, 2007.

IT IS FURTHER ORDERED that:

2. **Bridgit D. Geiger** shall make subsequent quarterly principal payments in the equal amount of \$1,625.00 on December 1, March 1, June 1, and September 1 of each year thereafter, until the balance of the costs in the amount of \$10,000.00 is paid in full, except that the final payment shall be in the amount of the outstanding balance of the costs in the amount of \$250.00, in accordance with the Amortization Schedule attached hereto as Exhibit A.

3. If **Bridgit D. Geiger** shall default in the payment of any installment of principal hereunder and such default shall continue for a period of ten (10) days after the receipt of written notice thereof to **Bridgit D. Geiger**, the unpaid principal balance of this Order shall be immediately due and payable, together with interest incurred from September 1, 2007 until the date of payment at the statutory rate of 12% per annum on the full amount of the principal balance of \$13,117.06.

4. **Bridgit D. Geiger** shall have the option to prepay without penalty, all or any portion of the unpaid principal balance owed at any time.

5. All payments of the costs shall be mailed, delivered or otherwise transmitted to:



It is hereby stipulated and agreed, by and between Bridgit D. Geiger, Respondent; and Mark A. Herman, attorney for Complainant, State of Wisconsin, Department of Regulation and Licensing, Division of Enforcement, as follows:

1. This Stipulation modifies an Order Fixing Costs issued in case number LS0605153RSG. The Order Fixing Costs was issued following hearing in which the Department of Regulation and Licensing (Department) concluded that Respondent engaged in unprofessional conduct, revoked Respondent's license, and ordered Respondent to pay the costs of the proceedings. Respondent consents to the modification of the Order Fixing Costs in lieu of petitioning for judicial review of this matter in accordance with the provisions of §§227.52 and 227.53, Wis. Stats.

2. Respondent understands that by signing this Stipulation she voluntarily and knowingly waives all applicable rights afforded to her under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and any other provisions of state or federal law.

3. Respondent has obtained the advice of legal counsel prior to signing this Stipulation.


4. Respondent agrees to the adoption of the attached Amended Order Fixing Costs by the Department. The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Department's Final Decision and Order, if adopted in the form as attached.

5. If the terms of this Stipulation are not acceptable to the Department, the parties shall not be bound by the contents of this Stipulation, and the Order Fixing Costs shall not be modified and shall stand, unless Respondent seeks judicial relief in accordance with the provisions of §§ 227.52 and 227.53, Wis. Stats. If this Stipulation is not accepted by the Department, then the parties agree that they will not contend that the Department has been prejudiced or biased in any manner by the consideration of this attempted resolution.

6. The parties to this Stipulation agree that the attorney or other agent for the Division of Enforcement may appear before the Secretary of the Department, without the presence of Respondent or her attorney, for purposes of speaking in support of this agreement and answering questions that any person may have in connection with the Department's deliberations on the Stipulation.

7. Respondent is informed that should the Department adopt this Stipulation, the Department's Amended Order Fixing Costs is a public record and will be published in accordance with standard Department procedure.

8. The Division of Enforcement joins Respondent in recommending that the Department adopt this Stipulation and issue the attached Amended Order Fixing Costs.




