PROCEDURAL HISTORY

On June 22, 2006, the State of Wisconsin Chiropractic Examining Board (Board) reviewed Gary J. Luhman, D.C., (Respondent) petition for restoration of full licensure, pursuant to his completion of the requirements set forth in the Board's Final Decision and Order dated June 22, 2006.

FINDINGS OF FACT

1. By Order dated June 2, 2006, the Board imposed conditions upon the Respondent's license.
2. After review of the Respondent's petition and the evidence submitted to the Board the Board finds that the Respondent has completed all of the terms and conditions imposed upon his license by the June 22, 2006, Board Order.

CONCLUSION OF LAW

The Chiropractic Examining Board has jurisdiction and authority in this matter, pursuant to Wis. Stat., s. 446.03.

ORDER

Based upon the Board's review, IT IS HEREBY ORDERED that the license of Gary J. Luhman, D.C., to practice Chiropractic in the State of Wisconsin is hereby restored to full and unrestricted status.
