ORDER OF SUSPENSION

On March 15, 2007, the Pharmacy Examining Board issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent, Westby Pharmacy, was to have a signed offer for the sale of the pharmacy by April 11, 2007 and to provide proof to the Board Monitor by April 12, 2007 of the signed offer for the sale of the pharmacy. The Board Monitor did not receive proof by April 12, 2007, of an offer signed by April 11, 2007.

On April 12, 2007, the board considered evidence that Westby Pharmacy, c/o Gary Miller, has not been in compliance with the board ordered requirement of providing proof that the pharmacy has a "signed" offer for the sale of the pharmacy by April 11, 2007.

ORDER

NOW, THEREFORE, IT IS ORDERED that the license of Westby Pharmacy (#42-5674), is hereby suspended effective immediately.
