On August 30, 2007, the Board of Nursing filed its Final Decision and Order in the above-captioned matter and pursuant to sec. 440.22, Wis. Stats., ordered that the costs of this proceeding be assessed against respondent. On or about September 4, 2007, the Board of Nursing received the Affidavit of Costs of the Office of Legal Counsel filed by Administrative Law Judge Dennis Schuh, pursuant to sec. RL 2.18 (4), Wis. Admin. Code. On or about September 12, 2007, the Board of Nursing also received the Affidavit of Costs filed by Attorney Pamela M. Stach, Division of Enforcement, which listed those costs solely attributable to the respondent and those partially attributable to her. On October 4, 2007, the Board of Nursing considered the Affidavits of Costs and the respondent's Objections to the Affidavits. Based upon the information presented, the Board of Nursing made a motion to fix the costs. The amount of the costs was subsequently recalculated due to a scrivener's error to reflect the costs that were attributable proportionally to the respondent.

ORDER

NOW, THEREFORE, IT IS ORDERED that pursuant to sec. 440.22, Wis. Stats., the total costs of this proceeding attributable to the respondent of **\$2,563.17**, as set forth in the Affidavits of Costs of Attorney Pamela Stach and Administrative Law Judge Dennis Schuh, which are attached hereto are hereby assessed against respondent, and shall be payable by respondent to the Department of Regulation and Licensing. **Failure of respondent to make payment in six (6) months shall constitute a violation of the Order unless respondent petitions for and the Board of Nursing grants a different deadline.** Under sec. 440.22 (3), Wis. Stats., the Department of Regulation and Licensing may not restore, renew or otherwise issue any credential to the respondent until respondent has made payment to the department in the amount assessed.
