#### **PROCEDURAL HISTORY**

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

#### **FINDINGS OF FACT**

- 1. Neso's Village Barber Shop is duly licensed as a barbering and cosmetology establishment in the State of Wisconsin having license #080 0034067. This license was granted on 05/31/06.
- 2. Neso's Village Barber Shop most recent address on file with the Department of Regulation and Licensing ("Department") is: 7212 West State Street, Wauwatosa, WI 53213.
- 3. Perry L. Hansen, date of birth: 11/12/38, is listed as the owner of Neso's Village Barber Shop. Department records indicate that Mr. Hansen holds a barbering and cosmetology manager's license, #081 08787. This license was first granted on 11/16/65.
- 4. Mr. Hansen's most recent address on file with the Department is: 7033 Auburn Avenue, Wauwatosa, WI 53213.
- 5. As the manger of record and owner of Neso's Village Barber Shop, Mr. Hansen was and is at all times relevant to this action responsible for compliance with Wisconsin Statutes, Chapter 454 and the Wisconsin Administrative Code for Barbering and Cosmetology Chapters BC 2 and 3.

- 6. On or about February 1, 2006, the Department received a newspaper article stating that a client had been bit by a dog at Neso's Village Cuts on November 23, 2005. A true and correct copy of the newspaper article is attached as Exhibit A, and is incorporated by reference into this document.
- 7. On or about May 9, 2006, an inspection of Neso's Village Cuts was conducted by a Department investigator. The May 9, 2006 inspection revealed that Mr. Hansen was operating a barbering and cosmetology booth rental without first obtaining an establishment license.
- 8. The Department's investigation revealed that Mr. Hansen began operating a barbering and cosmetology booth rental on or about April 3, 2006.
- 9. Department records indicate that Mr. Hansen obtained an establishment license for Neso's Village Barber Shop on May 31, 2006.
- 10. In resolution of this matter, Perry L. Hansen and Neso's Village Barber Shop consent to the following Conclusions of Law and Order.

#### **CONCLUSIONS OF LAW**

- 1. The Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 454.15.
- 2. The Barbering and Cosmetology Examining Board is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
  - 3. Respondents Perry L. Hansen and Neso's Village Barber Shop have violated:

Wis. Stat. § 454.08 (1)(b) and Wis. Admin. Code §§ BC 2.04(1); 2.045(1); 3.01(1) and 3.02(2)(b) by operating a booth rental without obtaining an establishment license.

#### **ORDER**

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED, that the Respondents are hereby **REPRIMANDED** for the violations set forth above.

IT IS FURTHER ORDERED, that the Respondents shall jointly and severally pay to the Department of Regulation and Licensing a forfeiture of **TWO HUNDRED FIFTY DOLLARS (\$250.00)**.

IT IS FURTHER ORDERED, that Respondents shall jointly and severally pay costs in this matter in the amount of **TWO HUNDRED FIFTY DOLLARS (\$250.00).** 

IT IS FURTHER ORDERED, that a down payment of **TWO HUNDRED FIFTY DOLLARS** (\$250.00) shall be sul within thirty (30) days from the date of this order and one more payment of **TWO HUNDRED FIFTY DOLLARS** (\$250.0 be due sixty (60) days from the previous payment until the full **FIVE HUNDRED DOLLARS** (\$500.00) is paid. IT IS FURTHER ORDERED, that in the event that Perry L. Hansen and Neso's Village Barber Shop fail to timely submit payment of the forfeiture and costs as set forth above, the barbering and cosmetology manager's license for Perry L. Hansen (#081 08787) and the establishment license for Neso's Village Barber Shop (# 080 034067) **SHALL BE SUSPENDED**, without further hearing and without further Order of the Board, and said suspension shall continue until the full amount of said costs has been paid to the Department of Regulation and Licensing and their failure to pay the costs shall be considered a violation of this Order by the Board.

IT IS FURTHER ORDERED, that file 06 BAC 016, be and hereby is, closed as to Perry L. Hansen and Neso's Village Barber Shop.
