SUMMARY

This Class 1 proceeding was commenced in March 2007 after the applicant requested a hearing following the denial by the Wisconsin Department of Regulation and Licensing of the applicant's application for certification. A hearing was originally scheduled for May 17, 2007. On April 5, 2007, the Department of Regulation and Licensing received a written request from the applicant's attorney that his request for hearing be withdrawn.

FINDINGS OF FACT

1. The applicant, Thomas J. Novak, has requested that his request for hearing on the denial of his application for certification be withdrawn.

ORDER
