#### **PROCEDURAL HISTORY**

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Stipulation comes after the issuance of barbering and cosmetology citations. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

#### **FINDINGS OF FACT**

- 1. Mary Lou Behring, d/o/b: 01/21/56, is duly licensed as a barbering and cosmetology manager in the state of Wisconsin having license #081-16303. This license was first granted on 02/06/84.
- 2. Ms. Behring's last known reported business address on file with the Department of Regulation and Licensing ("Department") is: 123 N. Henry Street, Edgerton, Wisconsin 53534.
  - 3. The Hair Chair is duly licensed as a barbering and cosmetology establishment in the state of Wisconsin having

license #080-26172. This license was first granted on 01/17/97.

- 4. The Hair Chair's last known reported business address on file with the Department of Regulation and Licensing ("Department") is: 123 N. Henry Street, Edgerton, Wisconsin 53534.
- 5. Ms. Behring is listed as the owner of The Hair Chair. At all times relevant to the facts stated below, Ms. Behring is responsible for compliance with chapter 3 of the Wisconsin Administrative Code.
- 6. On or about May 2, 2007 an inspection of The Hair Chair was conducted by a Department investigator. The inspection revealed the salon was not being maintained in an orderly and sanitary condition. Based on the results of the inspection, Ms. Behring received barbering and cosmetology citations.
- 8. On May 16, 2007, the Respondent requested a hearing on the issuance of the barbering and cosmetology citations.
- 9. In resolution of this matter, Ms. Behring and The Hair Chair consent to the entry of the following Conclusions of Law and Order.

#### **CONCLUSIONS OF LAW**

- 1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. Sec. 454.15, and the Wisconsin Barbering and Cosmetology Examining Board is authorized to enter into the attached stipulation pursuant to Wis. Stat. Sec. 227.44(5).
  - 2. By the conduct referred to in the above Findings of Fact, Mary Lou Behring and The Hair Chair have violated:

Wis. Admin. Code § BC 3.01(1) for failing to maintain an orderly and sanitary salon.

#### **ORDER**

NOW, THEREFORE, IT IS HEREBY ORDERED that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED, that the Respondents shall jointly and severally pay a FORFEITURE of ONE HUNDRED dollars (\$100.00).

IT IS FURTHER ORDERED, that the Respondents shall jointly and severally pay COSTS in this matter in the amount of THIRTY dollars (\$30.00).

IT IS FURTHER ORDERED, that payment of the forfeiture and costs shall be paid within thirty (30) days from the signing of this Order.

Payment shall be made by *certified check or money order*, payable to the Wisconsin Department of Regulation and Licensing and sent to:

Department Monitor Division of Enforcement PO Box 8935 Madison, WI 53708-8935 Telephone 608-261-7904 Fax 608-266-2264 IT IS FURTHER ORDERED, that in the event that if Mary Lou Behring and The Hair Chair fail to timely submit payment of the forfeiture and costs as set forth above, Mary Lou Behring's, barbering and cosmetology manager's license #081 0016303 and The Hair Chair barbering and cosmetology establishment license #080 0026172 **SHALL BE SUSPENDED,** without further hearing and without further Order of the Board, and said suspension shall continue until the full amount of said partial costs has been paid to the Department of Regulation and Licensing and their failure to pay the costs shall be considered a violation of this Order by the Board.

IT IS FURTHER ORDERED, that file, 07 BAC 046 be, and hereby is, closed as to all Respondents.
