PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Charles D. Wilson (D.O.B. 10/9/52) is duly licensed in the state of Wisconsin as a practical nurse (license # 30561). This license was first granted on 11/22/90, and was not renewed when it expired on 4/30/07. Under Wis. Stat. § 440.08(3), Respondent may renew his license at any time until 4/30/12, by payment of the then-due statutory renewal and late fees.
2. Respondent is under investigation for diverting medication in 2004, from patients at a long term care facility where he worked. Respondent denies any wrongdoing.
3. Respondent is presently physically disabled by conditions which cause persistent pain, and is physically unable to practice nursing. He chose not to renew his license solely for this reason.

CONCLUSION OF LAW

If the conduct described in par. 2, above, were proved, respondent would be subject to disciplinary action against his license to practice as a nurse in the state of Wisconsin, pursuant to Wis. Stat. § 441.07(1)(b), (c) and (d), and Wis. Adm. Code §§ N 7.03(1)(a), (b), (c), (e), and N 7.04(1) and (15).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that the SURRENDER of the right to renew the license to practice nursing of Charles D. Wilson, L.P.N., is ACCEPTED. Respondent shall not renew or attempt to renew his Wisconsin license to practice nursing. Respondent shall not practice nursing in Wisconsin, including under the Nurse Licensure Compact, without a license from the Board.

IT IS FURTHER ORDERED, that if Respondent ever seeks reinstatement, this case shall be reopened and the allegations fully investigated. The Board may condition reinstatement on any terms which it deems appropriate at that time, including but not limited to the payment of costs under Wis. Stat. § 440.22.
