PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Barbering And Cosmetology Examining Board. The has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Juana Palomares, (DOB 1/14/1967) is duly licensed as a barbering or cosmetology practitioner in the State of Wisconsin (license # 83409-82). This license was first granted on 6/21/2004.
2. Respondent's most recent address on file with the Department of Regulation and Licensing is 731 Johnson Street, Beloit, WI 53511.
3. At all times relevant to this action, Respondent was working as a barbering or cosmetology practitioner at 169 West Grand Avenue, Beloit, WI 53511.
4. On December 8, 2005, Investigator Willie Garrette and Attorney Angela Arrington made an unannounced visit to 169 West Grand Avenue, Beloit, WI 53511.
5. Investigator Garrette and Attorney Arrington found an unlicensed establishment named Estetica Express operating at the Grand Avenue address. Respondent is the owner of Estetica Express.
6. Investigator Garrette and Attorney Arrington observed Respondent providing cosmetology services to a patron.
7. At the time of the visit, Respondent had not been granted an establishment permit to operate Estetica Express.
8. Respondent holds a barbering and cosmetology practitioner credential and had not employed a person holding a barbering and cosmetology manager credential as manager for the establishment.

9. Respondent was granted an establishment license for Estetica Express on January 30, 2006.

CONCLUSIONS OF LAW

1. The Wisconsin Barbering And Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 454.15 (2), and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stats. § 227.44 (5).
2. The conduct described in paragraphs seven and eight above constitutes a violation of § 454.08 (1) (b) and (6).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that Respondent shall pay to the Department of Regulation and Licensing a forfeiture of **ONE THOUSAND** dollars (\$1000.00).

IT IS FURTHER ORDERED that Respondent shall pay costs in the amount of three hundred dollars (\$300.00).

Payment of the forfeiture and costs shall be submitted in four (4) installments. The installments shall be made paid on the following payment schedule:

Respondent may pay the full amount of the forfeiture and costs at any time prior to each due date for payment.

1. **Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to submit timely any payment of the forfeiture as set forth above, or fails to pay costs as ordered, license (#82-83409) and the establishment license of Estetica Express (#80-33754) SHALL BE SUSPENDED, without further notice or hearing until Respondent has complied with the terms of this Order.**

2. This Order is effective .
