On October 17, 2007, the Wisconsin Medical Examining Board considered the petitioner's request for a further three month stay of suspension and a reduction in his therapy sessions, pursuant to the Board order dated June 16, 2004. Based upon the information of record which shows that the petitioner is in compliance with his Board order, and the request for a reduction in therapy is supported by his therapist, the Board finds and enters the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a three month stay of the suspension of the medical license of Benjamin W. Begley, M.D. (lic.# 20-29405) is hereby GRANTED.

IT IS FURTHER ORDERED that the petitioner's request for a reduction in his therapy is GRANTED. The petitioner's therapy shall be decreased to one (1) session per month.

This Order is effective upon the date of signing and shall be continuous from the date of the previous stay.
