On February 1, 2005, the Department of Regulation and Licensing issued an Order granting Brett Polensky a limited license (#94-62635) to practice as a real estate salesperson in the state of Wisconsin. By the terms of the department's order, Mr. Polensky's license was suspended for five years, with that suspension being immediately stayed and Mr. Polensky being placed on a limited license. The Order further provided that failure by Mr. Polensky to comply with the limitations of his license would result in removal of the stay and re-imposition of the suspension.

The Department Monitor has received information that Mr. Polensky is in substantial violation of the February 1, 2005 order. Mr. Polensky has failed to abstain from personal use of alcohol and pled no contest to Operating While Intoxicated (5th+ offense) on or about May 30, 2008. Mr. Polensky has also failed to comply with other requirements of the order.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that the stay of suspension is removed and the limited real estate salesperson license of Brett Polensky (#94-62635) is SUSPENDED.

This Order shall become effective on the date of signing.
