Ardie J. Thomas ("Petitioner") was granted a private security guard permit with limitations (#108-32315) by Order dated November 16, 2006. On March 30, 2007, the Department of Regulation and Licensing considered and granted a petition offered by the Petitioner for full and unrestricted licensure on her private security guard permit. On June 21, 2007, the Department issued the Petitioner a private security guard permit without limitations.
