On February 28, 2008, the Board of Nursing reviewed the petitioner's request for reinstatement of his nursing license and stay of suspension pursuant to the Board order dated May 3, 2001. Based upon the information presented which shows that the petitioner been in practice in the state of Illinois under a monitoring program and that the petitioner has a letter of support from his therapist, the Board finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement of the limited registered nurse license of PAUL LAUER, R.N. (lic. # 106610) and stay of suspension shall be GRANTED.

IT IS FURTHER ORDERED that the petitioner shall be required to submit quarterly satisfactory work reports and shall submit to random drug testing at the frequency of fourteen (14) screens per year.

IT IS FURTHER ORDERED that petitioner may be receive credit for the time period of his compliance in Illinois if provides official documentation of his compliance.
