On July 24, 2008, the Wisconsin Board of Nursing considered the petitioner's request for a three month stay of suspension and a reduction in her drug screens. Based upon the information of record which shows the petitioner's compliance with the terms and conditions of the Board's original order dated December 14, 2001, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a three month stay of suspension of the registered nursing license of ROBIN J. SWIGGUM, RN, (lic.#119898), is hereby GRANTED.

IT IS FURTHER ORDERED that the petitioner's request for reduction in drug screens is hereby GRANTED. Petitioner's drug screens shall be reduced to thirty-one (31) per year.

This Order is effective upon the date of signing and the stay is retroactive to the date of the previous stay.
