On February 28, 2008, the Board of Nursing reviewed the petitioner's request for full reinstatement of her nursing license pursuant to the order of the board dated January 4, 2002. In the alternative, the petitioner requested a three month stay of suspension and a reduction in her drug testing and therapy requirements. Based upon the information of record which shows that the petitioner has not achieved two years of satisfactory compliance with the order, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that request for full reinstatement of the registered nurse of HOLLY B. LAVOIE, RN (lic. #119837) is hereby DENIED.

IT IS FURTHER ORDERED that the petitioner's request for a stay of suspension for three months is hereby GRANTED.

IT IS FURTHER ORDERED that the petitioner's drug testing shall be decreased to thirty-one (31) screens per year and her therapy sessions shall be discontinued. This order shall be effective upon the date signed and the stay is continuous from the previous stay.
