ORDER GRANTING THREE MONTH STAY OF SUSPENSION AND PARTIAL MODIFICATION OF BOARD ORDER

On January 24, 2008, the Board of Nursing considered the Petitioner's request for a three month stay of suspension, pursuant to the order of the Board dated January 25, 2005, and the following modifications to the order; 1) a decrease in petitioner's therapy sessions, 2) petitioner's access to controlled substances at her workplace, and 3) a reduction in petitioner's drug random screens. Based upon all information of record relevant to the petition, the Board finds and orders as follows:

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the request for a three month stay of suspension of the license of BARBARA J. BENOIT, (lic. #82241) to practice as a registered nurse in Wisconsin is hereby GRANTED.

IT IS FURTHER ORDERED that the request for modification of Petitioner's order to allow access to controlled substances is hereby GRANTED. Petitioner's therapy shall be reduced to one session per month.

IT IS FURTHER ORDERED that the petitioner's random drug screens shall remain at the frequency of fifty-two (52) times per year.
