PROCEDURAL HISTORY

On September 9, 2004, Warren A. Witkowski's license to practice chiropractic was suspended by the Wisconsin Chiropractic Examining Board (Board) and conditions were imposed for the reinstatement of his license. On November 30, 2006, Andrew Wagener, Warren A. Witkowski's attorney, filed a petition with the Board to terminate the suspension of Warren A. Witkowski's license and to reinstate his license. On April 12, 2007, the Board issued an Order reinstating Dr. Witkowski's license and placing limitations on his license.

On July 22, 2008, the Board received a Motion to Modify a Disciplinary Order from Dr. Witkowski's attorney, Andrew Wagener. That motion asked for the full reinstatement of Dr. Witkowski's license. Dr. Witkowski appeared at the Board's August 14, 2008, meeting in support of his petition. The Board heard his testimony, reviewed the submitted documents and deliberated on the motion. The Board decided to remove five of the limitations in the Board's April 12, 2007 order, and to retain two limitations with additional direction. The Board retained the two limitations to ensure that the acts that resulted in Dr. Witkowski's discipline will not reoccur.

The Board acknowledges and is pleased with Dr. Witkowski's continued efforts and the progress he has made.

IT IS HEREBY ORDERED THAT, the limitations imposed on Dr. Witkowski's license in the April 12, 2007 are removed except for the following limitations which remain on his license:

- 1. A female employee must be present in the room when Warren A. Witkowski, D.C., performs adjustments on any female patient;
- Warren A. Witkowski, D.C., must maintain his sexual harassment policy in his office. Warren A.
 Witkowski, D.C., is further directed to modify his current policy to have all claims of sexual harassment reported to Dr.
 Ford or another chiropractor approved by the Board.
