On December 4, 2008, the Wisconsin Board of Nursing considered the petitioner's request for full reinstatement of his registered nurse license, pursuant to the Board order dated February 2, 2003. Based upon all information of record showing the petitioner's pattern of missed call-ins for his urine drug screens, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the petitioner's request for full reinstatement of the limited license of Richard K. Romer (lic. #118733) to practice as a registered nurse is hereby DENIED.

IT IS FURTHER ORDERED that the petitioner shall be GRANTED a stay of suspension for a period of two months.

IT IS FURTHER ORDERED that any future missed calls for drug screens by the petitioner shall result in a minimum six (6) month suspension.

This order is effective upon the date signed below and the stay shall be continuous from the date of the previous stay.
