On November 6, 2008, the Wisconsin Board of Nursing considered the petitioner's request for full reinstatement of his registered nurse license pursuant to the board order dated February 7, 2003. Based upon the information of record regarding possible non-compliance with the drug screens, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a full reinstatement of the nurse license of RICHARD ROMER, R.N. (lic. # 118733) is hereby DENIED.

IT IS FURTHER ORDERED that the petitioner shall be GRANTED a stay of suspension for a period of one month. The Board will review information regarding the petitioner's compliance with his drug screens at the next monthly meeting.

This stay is effective on the date of the order below and is continuous from the date of the previous stay.
