John P. Murphy, D.C, (Respondent) was reprimanded and had limitations placed on his license by the Wisconsin Chiropractic Examining Board (Board), by order dated October 16, 2003. By letter dated September 11, 2008, The Respondent asked the Board to remove the limitation from his license, thereby restoring his license status to full licensure. At its October 16, 2008 meeting, the Board reviewed the information that the Respondent submitted in support of his request.

After review of the information submitted, the Board found no evidence that the Respondent had fully complied with the terms of the October 16, 2003, order.

THEREFORE IT IS HEREBY ORDERED that the Respondent's request for the reinstatement of full licensure is denied.
