ORDER GRANTING LIMITED LICENSE FOR NURSE REFRESHER COURSE

On January 24, 2008, the Wisconsin Board of Nursing considered the petitioner's request for reinstatement of her nursing license which had been surrendered pursuant to the order of the Board dated September 16, 2004. Based upon the information of record showing that petitioner has not renewed her license within five years of the renewal date and has not been employed as a nurse in another jurisdiction during this period, the Board finds and makes the following:

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that a limited license shall be GRANTED to SHEILA (STEINER) FERRON, L.P.N., for the sole purpose of completing a nurse refresher course approved by the Board.

IT IS FURTHER ORDERED that upon successful completion of the course, the petitioner may petition the Board for a L.P.N. license that is subject to a five year standard impairment order.

This Order is effective upon the date of signing.
