On January 24, 2008, the Wisconsin Board of Nursing considered the request of the petitioner for a stay of suspension of her nursing license, pursuant to the order of the Board dated December 9, 2004, and for modifications to her therapy and random drug screens requirements. Based upon the information presented, the Board finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a three month stay of the suspension of the registered nurse license of JENELLE M. DEBYLE, R.N. (lic. #125986) in the state of Wisconsin is hereby GRANTED.

IT IS FURTHER ORDERED that the petitioner's request for a reduction in her random drug screens and therapy is GRANTED. Petitioner's screens shall be decreased to twenty-six (26) times per year. Petitioner's therapy sessions shall be reduced to one time per month.

This Order is effective upon signing and the stay is continuous from the date of the previous stay.
