On November 12, 2008, the Medical Examining Board considered the petitioner's request for a stay of suspension of his license to practice as a respiratory care practitioner in the state of Wisconsin pursuant to the Board order dated September 14, 2005. Based upon the information of record presented showing that the petitioner has not maintained compliance with the drug screens required by the Board order, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement of the stay of suspension of the limited license of Jene Van Den Hout. RCP, (lic. # 1504) to practice as a respiratory care practitioner in Wisconsin is hereby DENIED based upon his non-compliance with the Board order.

IT IS FURTHER ORDERED that the petitioner may reapply for a stay of suspension when he has achieved three months of satisfactory compliance with the Board order.
