On May 1, 2008, the Wisconsin Board of Nursing considered the petitioner's request for a stay of suspension and modifications to the board order dated March 9, 2006; a reduction in her therapy requirement and a decrease in the frequency of her random drug screens. Based upon the information presented which shows the petitioner has been in compliance with the terms and conditions of the order, the Board now finds and enters the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a three month stay of suspension of the license of ERIN K. HOREJS, R.N. (lic.#142262) to practice as a registered nurse in Wisconsin is hereby GRANTED.

IT IS FURTHER ORDERED that the request to reduce the petitioner's therapy sessions to one time per quarter is GRANTED.

IT IS FURTHER ORDERED that the frequency of the petitioner's drug screens shall be decreased to thirty-one (31) per year. This Order is effective upon the date of signing.
