On November 7, 2007, the State of Wisconsin Dentistry Examining Board reviewed the petition by Gretchen K. Evenson, asking the Board to modify the terms of an Order dated May 3, 2006, that imposed discipline on Dr. Evenson. Dr. Evenson asked the Board to reduce her random drug and alcohol screens from 105 to 52 times a year and to reduce the number of required therapy sessions from 52 to 20 times a year. The Board reviewed the materials submitted by Dr. Evenson. Based on the review of the record the Board issues the following Order.

IT IS HEREBY ORDERED that Dr. Evenson's petition to reduce the number of annually required random urine screening tests from 105 to 52 with 26 being standard panel screens and 26 being Etg screens is Granted.

IT IS ALSO ORDERED that Dr. Evenson's petition to reduce the number of annually required therapy sessions from 52 to 20 is Granted.
