The Barber and Cosmetology Examining Board issued an Order December 3, 2007, which affixed the costs of the proceeding against the Respondents. The deadline for filing an objection to the order affixing costs was October 10, 2007. On about January 14, 2008, the Board received written objections to the costs by the Respondent's attorney Khaja M.Din. The Complainant's attorney, Claudia Berry Miran, filed a response to the Respondent's objections on January 25, 2008.

Although the objections were filed late, the Board decided to review the costs. At its February 4, 2008, meeting the Board reviewed the documents and heard oral arguments from the parties. After deliberation, the Board found that there is a reasonable basis in fact and in law and that the costs are substantially justified.

THEREFORE IT IS ORDERED THAT, the Respondent's Petition for a Modification of affixed costs is DENIED.
