This matter was considered by the Hearing and Speech Examining Board at its regular meeting on April 14, 2008.

BACKGROUND

An evidentiary hearing in the above-captioned matter was held on November 21, 2006. Atty. Gilbert C. Lubcke appeared on behalf of the Division of Enforcement. The Respondent, Andrew R. Arnold, appeared without legal counsel. The Administrative Law Judge issued her proposed decision on May 29, 2007. The Board considered the proposed decision at its meeting on August 6, 2007 and adopted the proposed decision with variances. In the Board's Final Decision and Order, which is dated September 10, 2007, the Board ordered Mr. Arnold to pay full costs of the proceeding. The Board's Order Fixing Costs, which is dated November 5, 2007, provides that Mr. Arnold shall pay costs in the amount of \$7,599.38.

On January 1, 2008, Mr. Arnold paid \$1,000 towards the costs assessed against him. He paid an additional \$200.00 of the costs on March 18, 2008. At some point in time after the Board issued its Order Fixing Costs, Mr. Arnold submitted a request to the Board for an extension of time to pay the costs assessed against him. The Board considered Mr. Arnold's request at its April 14, 2008 meeting.

Based upon the record in this matter, the Board makes the following Order:

ORDER

NOW, THEREFORE, IT IS ORDERED that the Respondent, Andrew R. Arnold, be and hereby is, granted an extension of time to pay the full costs assessed in the above-captioned matter as follow: Respondent shall pay \$500.00 or more each month, plus interest, with the condition that he pays the total amount of the costs in full by January 31, 2009.

This order is effective on the date it is signed by a designee of the Hearing and Speech Examining Board.
