On February 22, 2008, the Department of Regulation and Licensing filed its Final Decision and Order in the above-captioned matter by which the department ordered that pursuant to sec. 440.22, Wis. Stats., three-fifth of the costs of this proceeding be assessed against respondents. Pursuant to sec. RL 2.18 (4), Wis. Admin. Code, on or about February 28, 2008, the Department of Regulation and Licensing received the Affidavits of Costs in the amount of \$2,420.87, filed by Attorney Mark Herman. On or about March 6, 2008, the Department of Regulation and Licensing received the Affidavit of Costs of the Office of Legal Counsel in the amount of \$2,046.49, filed by Administrative Law Judge Colleen M. Baird. Three-fifths of the assessable costs is \$2,680.42. The Department of Regulation and Licensing considered the Affidavits of Costs on April 8, 2008, and orders as follows:

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that pursuant to sec. 440.22, Wis. Stats., three-fifths of the total costs of this proceeding in the amount of \$2,680.42, set forth in the Affidavits of Costs of Attorney Mark Herman and Administrative Law Judge Colleen M. Baird, which are attached hereto and made a part hereof, are hereby assessed against respondents, and shall be payable by respondents to the Department of Regulation and Licensing. **Failure of respondents to make payment on or before May 9, 2008, shall constitute a violation of the Order unless respondents petition for and the department grants a different deadline.** Under sec. 440.22 (3), Wis. Stats., the Department of Regulation and Licensing may not restore, renew or otherwise issue any credential to the respondents until respondents have made payment to the department in the full amount assessed.
