On September 17, 2008, the Wisconsin Medical Examining Board considered the petitioner's request to modify the order of Board dated November 14, 2007, to remove the term "limited" which appears in the order. Based upon the information presented, the Board does not find good cause for modifying the language because it was the intent of the Board to impose a limitation upon the petitioner's medical license prohibiting him from the practice of obstetrics. Accordingly, the Board makes the following:

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the petitioner's request for modification of the terms in the disciplinary order dated November 14, 2007, involving the medical license of THEODORE G. GREEN, M.D. (lic.# 21-16986) is hereby DENIED.
