ORDER GRANTING STAY OF SUSPENSION AND PARTIAL MODIFICATIONS TO BOARD ORDER

On July 16, 2008, the Medical Examining Board considered the petitioner's request for a continuation of the stay of the suspension of his medical license and for modifications to the Board order dated January 24, 2007, which is currently in effect. The information of record shows that the petitioner has been in compliance with the Board order and that his therapist supports the modification of the order based upon the petitioner's strong recovery status and his ability to safely work as a physician. Based upon the information presented, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a continuation of the stay of the suspension of the medical license of JOEL C. JACOBSON, M.D. (lic. # 29643) in Wisconsin is hereby GRANTED.

IT IS FURTHER ORDERED that the request for modifications to the Board order is GRANTED in part as follows:

- 1) Paragraph C. 19 of the Order shall be modified to strike the first sentence of the first full paragraph to thereby allow the petitioner to prescribe, dispense, administer or order any controlled substances, with the remaining portions of that paragraph to remain in effect;
- 2) The second full paragraph of C.19 in the order shall be stricken in its entirety to allow the petitioner to reapply for a DEA registration for all scheduled drugs and not limited to only Schedule IV substances;
- 3) Petitioner's random urine screens shall be increased to ninety-six (96) per year when the petitioner commences employment as a physician in a board pre-approved setting.

IT IS FURTHER ORDERED that the petitioner's request for elimination of the professional mentor provision and a reduction in the minimum number of work hours necessary to receive credit toward the five years continuous successful compliance with the order is hereby DENIED.

IT IS FURTHER ORDERED that all other provisions of the original Board order, not modified herein, shall remain in effect until such time as modified by the Board.

This Order is effective upon the date of signing.
